## 1. Welcome / Apologies

Apologies received from Alan Bell (NW) and Stuart Johnson (VE Head of Development).

# 2. Review of Minutes of last Meeting (19 Feb 2011)

# 3. Matters Arising

3.1 Go Spike - Launch End May. Details expected mid May. Amy Seaman has been seconded to b-focused, the PR agency handling the Go Spike campaign for 3 days a week. Rachel Laybourne has been appointed to cover Amy's role for 2 days a week, for a 5 month period.

3.2 RTDP - Concern over the late appointment of divisional coaches (April 2011) and the effect this will have on players (who may find themselves excluded from the Inter Regionals, their expected competitive outlet from taking part in the RTDP.)

#### 4. HEVO (Zoe Matusiak)

Zoe had circulated a paper prior to the meeting. 30 HEVOs have been appointed at 28 universities. The first tranche attended a training day at end of March where they were given expectations of what is expected - Come & Try it sessions, Festivals within their university. HEVO were set individual targets. They should run a mass participation festival, most planned for Fresher's week. The target is 55 HEVOs. Plan to appoint senior HEVOs in each region who can help advise and mentor new appointments.

The communication path is directly from the HEVOs to Zoe at the National Office. We need to ensure that local communication is established as the HEVOs are likely to be key people in terms of contact for university teams in local leagues, in finding candidates or even providing facilities for courses.

#### Action: All Regions to provide Zoe with contact(s) in the Region. (All)

**Active Universities Grants** - 19 Sport England funded applications have specified volleyball.. There are 4 or 5 likely to drop volleyball as their plans may be too ambitious. The other bids will likely result in paid positions in various universities to co-ordinate the programmes.

#### 5. Regional Reports - All 9 regional reports received

#### 5.1 Change 4 Life School Sports Clubs

Concern was expressed by several regions that a good opportunity to engage with schools was slipping away, due to the change in the government, the ending of the PDM roles and non-ring fencing of the Change 4 Life monies.

Circulate list of schools, contacts, including who attended training courses, etc.

Action: (LW)

Change 4 Life is a big Department of Health programme and a second phase will be rolled out into primary schools. Funding of an equipment package is still to be agreed with an application to Sport England's Small Grants Scheme. (Keith Nicholls is working on an equipment package)

# 6. Discussion on the involvement of Regional Commission in the development of VE Initiatives

It was suggested that we needed to improve education, of both paid staff and volunteers, on how both groups works. It is important for all staff, but especially new, less experienced staff to be aware of the regional structure and this should be part of new staff induction. Lisa offered the commission members the opportunity to attend a national office team meeting.

#### 7. Regional Constitutions

Lisa gave brief background with respect to the 2010 Volleyball England Articles of Association and the need to change regional constitutions to comply with the Companies Act. This is not an attempt to enforce a common regional constitution, but to ensure that regions comply legally.
